WE PROVIDE DAY CARE FOR CHILDREN AGES 6 MONTHS TO 6 YEARS. KINGDOM HOUSE'S INFANT/TODDLER AND PRESCHOOL PROGRAMS HAVE ACCREDITATION UNDER THE MISSOURI VOLUNTARY ACCREDITATION PROGRAM. IT IS A MEMBER OF THE CHILD DAY CARE ASSOCIATION OF ST. LOUIS, WHICH PROVIDES TECHNICAL SUPPORT AND IN-SERVICE TRAINING. WE HAVE A HEALTH CHECK PROGRAM, USDA NUTRITION PROGRAM, SPECIAL NEEDS PROGRAM FOR DEVELOPMENTAL PROBLEMS, AND A FOSTER GRANDPARENT PROGRAM. HEADSTART AND EARLY HEAD START ARE INCORPORATED INTO THE DAY CARE PROGRAMS.

THESE PROGRAMS INCLUDE TUTORING, ARTS AND CRAFTS, COMPUTER PROGRAMS, PHYSICAL FITNESS, SPORTS, FIELD TRIPS AND A MEAL EACH DAY AFTER SCHOOL. KINGDOM HOUSE PROVIDES AN EIGHT-WEEK SUMMER CAMP WITH A WIDE RANGE OF SPORTS AND CAMP ACTIVITIES, AS WELL AS TWO MEALS EACH DAY. THE SPORTS PROGRAM INCLUDES ORGANIZED TEAM SPORTS. KINGDOM HOUSE IS A SAFE-HAVEN FOR OVER 500 CHILDREN AND YOUTH (6 TO 18 YEARS OF AGE). ALL SERVICES ARE PROVIDED WITHOUT CHARGE. THE FAMILY CENTER PROVIDES EMERGENCY/RESPITE CARE FOR UP TO TEN CHILDREN.

THERE WERE 2,196 CLIENT VISITS TO THE FOOD PANTRY, AND 719 CLIENT VISITS TO THE THRIFT STORE IN 2015.
